STATE OF WISCONSIN

Town of Harrison

Grant County

SECTION I – TITLE AND PURPOSE

The title of this ordinance is the Town of Harrison Comprehensive Plan Ordinance. The purpose of this ordinance is for the Town of Harrison, Grant County, Wisconsin, to lawfully adopt a comprehensive plan as required under s. 66.1001 (4) (c), Wis. stats.

SECTION II – AUTHORITY

The Town Board of the Town of Harrison, Grant County Wisconsin, has authority under its town powers under s. 60.22, Wis. stats., its power to appoint a town plan commission under ss. 60.42 (4) and 62.23 (1), Wis. stats., and under s. 66.1001 (4), Wis. stats., to adopt this ordinance. The comprehensive plan of the Town of Harrison must be in compliance with s. 66.1001 (4) (c), Wis. stats., in order for the town board to adopt this ordinance.

SECTION III – ADOPTION OF ORDINANCE

The Town Board of the Town of Harrison, Grant County Wisconsin, by this ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the town board present and voting, provides the authority for the Town of Harrison to adopt its comprehensive plan under s. 66.10001 (4), Wis. stats., and provides the authority for the town board to order its publication.

SECTION IV – PUBLIC PARTICIPATION

The Town Board of the Town of Harrison has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by s. 66.1001 (4) (a), Wis. stats.

SECTION V – TOWN PLAN COMMISSION RECOMMENDATION

The Plan Commission of the Town of Harrison by a majority vote of the entire commission, recorded in its official minutes, has adopted a resolution recommending to the town board the adoption of the Town of Harrison Comprehensive Plan, which contains all of the elements specified in s. 66.1001 (2), Wis. stats.

SECTION VI – PUBLIC HEARING

The Town of Harrison has held at least one public hearing on this ordinance, with notice in compliance with the requirements of s. 66.1001 (4) (d), Wis. stats.

SECTION VII – ADOPTION OF TOWN COMPREHENSIVE PLAN

The Town Board of the Town of Harrison by the enactment of this ordinance, formally adopts the document entitled Town of Harrison Comprehensive Plan Ordinance under s. 66.1001. (4) (c), Wis. stats.

SECTION VIII – SEVERABILITY
