#### SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Village of Cassville Comprehensive Plan Ordinance. The purpose of this ordinance is for the Village of Cassville, Grant County, Wisconsin, to lawfully adopt a comprehensive plan as required under s. 66.1001 (4) (c), Wis. stats.

#### SECTION II - AUTHORITY

The Village Board of the Village of Cassville, Grant County, Wisconsin, has authority under its village powers under s. 60.22, Wis. stats., its power to appoint a Village plan commission under ss. 60.62 (4) and 62.23 (1), Wis. stats., and under s. 66.1001 (4), Wis. stats., to adopt this ordinance. The comprehensive plan of the Village of Cassville must be in compliance with s. 66.1001 (4) (c), Wis. stats., in order for the Village board to adopt this ordinance.

#### SECTION III - ADOPTION OF ORDINANCE

The Village Board of the Village of Cassville, Grant County, Wisconsin, by this ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the Village board present and voting, provides the authority for the Village of Cassville to adopt its comprehensive plan under s. 66.1001 (4), Wis. stats., and provides the authority for the Village board to order its publication.

#### SECTION IV - PUBLIC PARTICIPATION

The Village Board of the Village of Cassville has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by s. 66.1001 (4) (a), Wis. stats.

#### SECTION V - VILLAGE PLAN COMMISSION RECOMMENDATION

The Plan Commission of the Village of Cassville by a majority vote of the entire commission, recorded in its official minutes, has adopted a resolution recommending to the Village board the adoption of the Village of Cassville Comprehensive Plan, which contains all of the elements specified in s. 66.1001 (2), Wis. stats.

#### SECTION VI - PUBLIC HEARING

The Village of Cassville has held at least one public hearing on this ordinance, with notice in compliance with the requirements of s. 66.1001 (4) (d), Wis. stats.

#### SECTION VII - ADOPTION OF VILLAGE COMPREHENSIVE PLAN

The Village Board of the Village of Cassville by the enactment of this ordinance, formally adopts the document entitled Village of Cassville Comprehensive Plan Ordinance under s. 66.1001 (4) (c), Wis. stats.

SECTION VIII - SEVERABILITY

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision of application, and to this end, the provisions of this ordinance are severable.

SECTION IX - EFFECTIVE DATE

This ordinance is effective on publication or posting.

The Village clerk shall properly post or publish this ordinance as required under s. 60.80, Wis. stats.
